

The Office for National Unity and Reconciliation invites bids for the creation of a musical symphony (Orchestral Performance) based on peace and reconciliation.

Bids are invited from creators with the qualifications and experience mentioned in Annexure 1 for the above work. Requirements ,

Qualifications and Experience:

1. At least a Master's or Diploma level in the subject of Music Creation.
2. Information about previous compositions.
3. At least 05 years of experience in music creation.

Conditions:

1. Photocopies of relevant certificates and a photocopy of the National Identity Card should be attached to the application form mentioned in Annexure 2 to prove all the qualifications mentioned in the application form.
2. The selected orchestral creator must agree to enter into a formal agreement with the Office for National Unity and Reconciliation.
3. No advance payment will be made and the bid value will be paid by cheque upon completion of the work.
4. To complete the work in a friendly manner with the music composer.
5. To accurately convey messages about society, culture and peace.
6. To create relevant themes and appropriate discourse for the creation of music orchestra.
7. The work must be completed and handed over within 60 days from the date of handover.
8. In case of any discrepancy between the bid value in figures and the bid value in words, the bid value in words shall prevail.

Designers who have the above qualifications, experience and are willing to agree to the conditions should submit bids as per Annexure 3.

Role of Orchestral Perform Creator

The primary task expected of the Orchestral Perform Creator is to create a Orchestral Performance of approximately one hour in length that signifies national unity for the Reconciliation Symphony to be created by the Office for National Unity and Reconciliation and to perform all other related activities. The musical symphony should be created with the approval of the Chairman of the Institute in accordance with the musical script presented by the composer and the music created by

the musical composer. The Office will not provide the necessary assistant creators, musicians, musical instruments, training facilities, transportation or other requirements and should agree to act in accordance with the guidelines provided for National Unity and Reconciliation.

Procedure to be followed for submitting bids

- Complete the Annexure 2 and 3 forms correctly.
- The completed applications should be placed in an envelope with the word “musical script writing” written on the top left hand corner and sealed and sent by registered post to the Director General, Office for National Unity and Regional Unity, No. 40, Butgamuwa Road, Rajagiriya before 02.30 PM on 09/03/2026 or can be dropped off in the tender box kept in the room of the Deputy Director Finance.
- Applications received after the due date and time and incomplete applications will be rejected. The final decision in this regard rests with the Procurement Committee.
